

SOUTH OC HYBRID HOMESCHOOL FINANCIAL AGREEMENT 2022-23

PROGRAM AND FEES

Annual program fees for the 2022-23 school year are as follows:

- SOCHH CORE: \$4680 SOCHH
- SOCHH Middle School (6th, 7th, 8th): \$5210
- SOCHH KINDERGARTEN Tu/Th: Half-day \$2800 OR Full-day \$3856
- SOCHH KINDERGARTEN Tu/Wed/Th: Half-day \$4200 OR Full-day \$5250
- SOCHH Math+: \$1800
- Extended Day Add-on to CORE & Middle School: \$1520

Fees include all required curriculum for the school year. If at any point we are mandated to a campus closure, a virtual learning schedule will be furnished and fees may be prorated at the discretion of the SOCHH board of directors.

ACKNOWLEDGEMENT

By signing below, I hereby enroll my child(ren) in South Orange County Hybrid Homeschool (herein referred to as SOCHH) for the term of August 16th, 2022 - June 1, 2023. I may pay the balance in full or in monthly installments. All required curriculum within each program are included in the fee. Classroom-specific materials and books requested by teachers are additional and optional.

I agree to pay the tuition and fees per school year, as indicated herein. I understand and acknowledge that SOCHH is a learning center of limited enrollment and that, in accepting this enrollment and tuition agreement form together with the non-refundable registration fee and tuition deposit, SOCHH agrees to provide a place for my child(ren) for the aforementioned term.

PAYMENT TERMS

I understand and agree to pay the program fees associated with the program I have enrolled my student(s) in. SOCHH accepts cash, credit card, check, and funds from select charters for payment of class fees due.

Payment can be made in full, or be divided into monthly installment payments. If payment for the annual class fee is made in full by August 31, 2022, a 10% discount will be applied to the invoice. If paying via installment payments, your full amount due will be divided into equal payments to be made monthly, with the first payment due on August 01, 2022.

All monthly payments are due by 1st of each month and considered delinquent if payment has not been received by the 25th of the month. This includes all forms of payments, including charter funds. I understand and agree to pay a late fee of \$100 on any balance unpaid by the 25th of the month. I understand a fee of \$25 will be charged to my account for any returned check or failed transaction.

Notification of any changes to your payment method must be sent to the Billing Department before payments are due/delinquent. Failure to provide timely notification which causes a delay in receipt of payment by SOCHH may result in a late fee incurred.

DEPOSIT/REGISTRATION FEE

I understand that there is a non-refundable registration fee of \$300.00 that serves as a placeholder for my student(s). This fee is required to be paid at the time of enrollment to confirm registration. If you are making monthly payments, this deposit will be applied as a credit to the last month's fee balance. If you are paying the annual class fee in full, this deposit will be deducted from your total due at the time of payment.

I understand that if we leave the program early for any reason this deposit will not be returned. The deposit will only be returned if SOCHH is not able to offer enrollment to your student due to a class being full.

CHARTER FUNDS

I understand that SOCHH may offer to accept applicable instructional funds on behalf of charter schools for my student(s) but that I remain financially responsible for ALL fees if/when charter funds are not successfully obtained for any reason. Should the charter be late or unable to pay, I understand I am responsible for this payment. I further understand and agree that the registration fee, books and supplies fees are not eligible for payment via charter funds and are non-refundable.

Charter funds are not received by SOCHH until 60 days after the month of service. For example, funds for January certificates are not received by SOCHH until March. If your charter funds are not received within this timeframe, you are obligated to pay for that month's class fees out of pocket. If and when that payment is received from your charter, your personal payment will be applied as a credit to your overall balance.

It is the parent's responsibility to communicate to the charter's vendor department regarding their payments and certificates. SOCHH does not have access to your charter account or balance and cannot order certificates on your behalf.

Students paying with charter funds must upload a copy of their purchase order/certificate to their Parent Portal no later than the 15th of the month. If a certificate is not received by this time, it will be assumed the full amount due is being paid out of pocket and an invoice for such will be added to the Parent Portal for payment. Neglect or violation of this policy will result in the possible discontinuation of SOCHH services unless there are extenuating circumstances that would need to be discussed and approved by the Director.

Charter funds can only be applied towards fees due within the same school year. SOCHH cannot request funds from charters for future fees to be saved and applied towards fees due in a future school year. If SOCHH received a charter certificate that exceeds the balance due on an account, the family will be required to provide a new certificate for the correct amount.

SOCHH reserves the right to discontinue acceptance of charter funds at any time. If this occurs, notice will be delivered to families in a timely manner.

ADDITIONAL COURSES

At times, SOCHH will offer courses outside of the required curriculum offered in your program. These courses are optional and any fees due must be paid out of pocket, charter funds cannot be used as payment. All due dates and late fee terms as outlined above are applicable to these courses.

WITHDRAWAL

If a student withdraws from SOCHH before the end of the year, parents agree to give 30 days written notice to administration and complete our Withdrawal Form. All SOCHH materials, including workbooks, library books, loaned devices, etc. must be returned.

501(c)3 NON-PROFIT

SOCHH is a registered 501(c)3 non-profit. Donation receipts will be provided for funds donated to this organization. Receipts will not be issued for services provided and/or products purchased by family. This includes, but is not limited to, class fees, deposits, yearbooks, and/or school pictures.

DISCLOSURE

No reduction or reimbursement is made for the withdrawal, dismissal, or absence of a student during the term for whatever reason, excepting the death or incapacity of my child(ren). I specifically agree to waive any claim against South OC Hybrid Homeschool for any losses or damages in any way associated with South OC Hybrid Homeschool's refusal to enroll the above named student(s) for any succeeding school year.

ARBITRATION

In the event it becomes necessary to institute legal action to reinforce the terms of this agreement, I agree that the matter shall be determined only by binding arbitration, according to the rules of the American Arbitration Association and, in the event that the academic program prevails in such action, I will pay the reasonable costs of that action, including reasonable attorneys fees incurred.
